Retirement Plan Oversight Committee Overview – Joey Payne	<ul> <li>Mr. Payne presented an overview of the Retirement Plan Oversight Committee meeting. Highlights of the proposed changes are:</li> <li>The committee is comprised of knowledgeable faculty and administrators.</li> <li>Cammack's role was discussed</li> <li>Fidelity and TIAA-Cref have lowered fees. Our members will see the difference</li> <li>Beginning April 1, 2015, participants will no longer be allowed to take out more than 3 loans against their retirement fund. Those who already have more than 3 loans will be grandfathered in, but may not take out any more loans until they have fewer than three outstanding</li> <li>Also beginning April 1, 2015, participants may only borrow against the employee contribution portion of their retirement account; they will no longer be allowed to borrow against the portion of fund contributed by UK. Participants will have prior notification of these changes.</li> <li>Retirement plan investment lineup will be discussed during EBC November meeting.</li> </ul>	No Action Needed.
